Accredited certifiers

The Joint Accreditation System of Australia and New Zealand (JAS-ANZ) undertakes the accreditation of conformity assessment bodies (or certification bodies) which is designed to enhance their status and authority both nationally and internationally and strengthens the international recognition and competitiveness of the Australian industry. Its mission is: "To ensure the JAS-ANZ accreditation process enhances trans-Tasman trade and achieves international recognition of the excellence of Australian and New Zealand goods and services."

Accreditation by JAS-ANZ is a measure of the competence, independence, integrity and impartiality of the conformity assessment bodies that in turn enables users (forest managers and owners for the AFS and processors, manufacturers, wholesalers, retailers and consumers for the CoC Standard) to have confidence in certificates of conformity that these conformity assessment bodies issue. JAS-ANZ also has mutual recognition with some 22 countries as part of Mutual Recognition Agreements, Multi-Lateral Agreements and Memorandums of Understanding, which provides enhanced opportunities for Australian suppliers of goods, services and products that have achieved accredited certification.

JAS-ANZ is a member of the International Accreditation Forum [www.iaf.nu] which promotes "Accreditation reduces risk for business and its customers by assuring them that accredited bodies are competent to carry out the work they undertake. Accreditation bodies which are members of IAF are required to operate at the highest standard and require the bodies they accredit to comply with appropriate international standards. Certificates issued by bodies accredited by members of the IAF Multilateral Recognition Arrangement (MLA) are relied upon all over the world because the MLA assures customers that the certificate is credible."

JAS-ANZ maintains a *Register of Accredited and Certified Organisations*, which lists all bodies accredited by JAS-ANZ, and all organisations and personnel certified under their accredited programmes. Accredited conformity assessment bodies are available for both the AFS and the CoC Standard. This enables both forest managers and owners, and firms or companies to have their forests or their link in the supply chain of wood and timber products certified to the relevant Australian Standard under the AFCS.
